Who We Are

The Ninilchik Village Tribe is made up of approximately 1,000 members who trace their roots to the Ninilchik tribal lands as well as other Bureau of Indian Affairs-recognized Alaskan Natives and American Indians who have settled in the tribal boundaries and have applied, and been accepted for membership. The governing body of the Ninilchik Village Tribe, the Ninilchik Traditional Council, is presided over by a board of directors of 5 council members elected by the voting tribal membership to 3 year terms. The Council directs executive staff using the Ninilchik Village Tribe’s Organic Documents, which are set by the voting tribal membership to exercise tribal operations and tribal sovereignty, as guidelines.

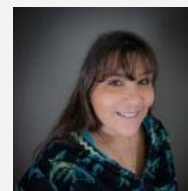

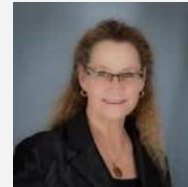

Executive Director's Address



As is customary this time of year, I anxiously awaited the wisdom and vision of ‘Punxsutawney Phil’. Unfortunately, the groundhog saw his shadow so we can expect six more weeks of winter. There’s no surprise there. With the marmot back in his hole and winter in full swing, I’d like to update you on a few things here at the Tribe.

We are closing in on the final completion of our two new buildings. The Tribal Services and Childcare facilities should be done by the end of the month. Tribal Services will begin moving into their new offices in March. The Childcare facility is also beginning to look at staffing and getting ready to open in the upcoming months. We have several positions open and some that will be posted in the near future, from assistants to childcare workers. Please look at current and future vacancy announcements if you are interested.

Our new clinical facility is open in Anchor Point. This project has not been without challenges; however, we are very happy with our small clinic in Anchor Point. Along these lines, we are pleased to announce that Family Nurse Practitioner, Peggy Westner, is providing primary care services there. Dr. Robin Holmes is also providing care in our Homer Clinic as well.

As I previously reported, we are continuing to make good progress on our new clinic in Homer, which will begin construction in the spring. Engineering is being finalized and we are on schedule to get plans, permitting, and bidding packets ready so that we can get started as soon as the building season begins.



Things are moving forward with the Q’eschil Heritage Center (QHC). We issued a request for qualifications for architectural design and development services. Our new website is also now live at geschil.org. Please check out the short video that was produced which eloquently shows the vision of some of the key stakeholders in imagining the development of the QHC. A big thanks goes out to Argent Kvasnikoff, Hanna Craig, and all those who participated in the video.

I am also pleased to report that we are continuing to work diligently on the development of our joint Intertribal Consortium with the Kenaitze Indian Tribe on our broadband project Nił qenach'delghesh, which means “we talk to each other”. We have adopted bylaws and appointed members to the Consortium, three from each Tribe. Maria Goins, NTC CFO, Greg Encelewski, NTC President/Chairman, and myself will represent Ninilchik. To date we are making good progress on funding applications under the new federal broadband monies that are available to tribes. We submitted a FY21 National Telecommunications and Information Administration (NTIA) Tribal Broadband Connectivity Program grant. The Consortium is also applying for a \$25 million dollar U.S. Department of Agriculture (USDA) Rural eConnect (ReConnect) grant. Things are happening and we are excited about the opportunity to bring broadband to our tribal communities.

On another exciting front, I submitted our State Small Business Credit Initiative (SSBCI) application. The total potential SSBCI funding is now at \$691,002, which we are seeking to put towards our business company, Tuyan, LLC. We are waiting on the final approval of our 8(a) status that will unlock the endless potential to bring in contracts with the federal government. Our partner, Cook Inlet Tribal Council, Inc. (CITC), is helping to make this endeavor a true success. It has been a pleasure to work with Carol Gore, Gloria O’Neill, CITC President/CEO, Amy Fredeen, CITC CFO, and our Interim General Manager, Matthew Hamilton, in making this come to fruition.

In closing, I hope you stay warm, healthy, and safe. Our clinic is doing a tremendous job in testing, along with medical care and treatment as we move through the pandemic. A huge thanks goes out to them for all they do. The Tribe is working hard to keep operations going smoothly as we move forward. All the best and thank you.

It Takes a Village

Childcare facility

As we prepare to open our new childcare facility, It Takes a Village, we are looking for trained providers or those interested and able to complete the required trainings to become a childcare provider. We are still working on the date for our grand opening, but we are looking to start securing trained providers to ensure the health and safety of children in care and help make this dream a reality!

Listed below are the basic training requirements to become a provider at It Takes a Village.

Background Checks:

Applicants must supply a copy of their criminal background checks from the Alaska State Troopers to be kept on file. The cost for this will be reimbursed through Tribal Services with a receipt of payment.

Fingerprinting:

As required by federal mandates, applicants must provide fingerprints to Tribal Services staff which will be reimbursed with a receipt of payment.

Adult, Child & Infant CPR/AED and First Aid Training:

Course MUST include in-person skills check to be valid, online only courses will not be accepted. Please check with Tribal Services Staff for dates for next available training courses. Accepted training courses that meet requirements will be reimbursed with receipt of payment.

Alaska State Mandatory Reporter Training:

This is a free online training that must be completed by applicants and copy of certificate kept on file with Tribal Services.

BKC Health and Safety Training Bundle:

Applicants must complete bundle of Health and Safety trainings through Penn State's online learning platform. The cost of the \$15 training bundle will be reimbursed through Tribal Services with a receipt of payment. Health and Safety Basics: Requirements for Certification can be found in the link listed below where you will be required to create an account to track your training courses.

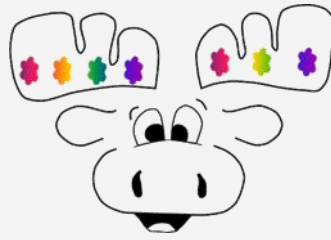

Food Handlers Card:

Applicants must obtain this certification to assist in serving food to children in care. It is an online course, and the cost (\$10) will be reimbursed through Tribal Services with a receipt of payment. Copy of certification will be kept on file with Tribal Services.

Hello Ninilchik Tribal Members,

I hope you have been staying warm and healthy during this nice and chilly start to our winter.

Before I get too far, I would like to let everyone know that I have a long-needed assistant helping me out here a couple of days per week. Her name is Kristen Gould. If you come by the NTC office on a Tuesday or Thursday, drop in and say hi.

We are still running the Treasury Emergency Rental Assistance program. This program is open to everyone of all races who reside within our Tribal Boundary Service area, and if the household income is within the median income limits for the Kenai Peninsula Borough. To receive this program, you must show or attest to being affected by Covid after March 2020. It is to help with temporary assistance with your rent and/or utilities if needed. If you are a Tribal member living in another state, we may be able to offer you help as well, as long as you fall within the median income limits for that borough's income limits, and have not received any State or Federal assistance for rental or utilities from another program. With the Homeownership Program, we are close to finishing up the next home in Ninilchik for a Ninilchik Tribal member. We have also purchased properties to build the next two homes. The preliminary engineering work has been finished and the soil/perk tests have been conducted and are out of the way. The home plans have been drafted up and we are ready to be putting both homes out for bid very early this spring.

We were also able to put a Ninilchik Tribal member into a home that we got back. These homes are instrumental in giving families the chance of a solid future and the Tribe should be very proud that it has such a great opportunity to change families in such a positive way.

We are still trying to find land in the Homer area, so if anyone knows of something that is affordable without the extreme Homer prices, please give me a call and let's see if we can work something out.

New Tribal Plan

Subject: Ninilchik Tribe Tribal Mitigation Plan

Ninilchik Tribe is kicking off the 2022 Ninilchik Tribe Tribal Hazard Mitigation Plan (THMP) process. THMPs are pre-disaster plans that are focused on reducing the impacts of disasters before they occur. In addition, Tribal governments that prepare THMPs are eligible for certain types of FEMA funding.

The 2022 THMP development process will take place over the next several months. Hazards addressed in the plan will include: Earthquakes, Climate Change, Floods, Erosion, Severe Weather, Ground Failure, Tsunami, and Wildland Fire.

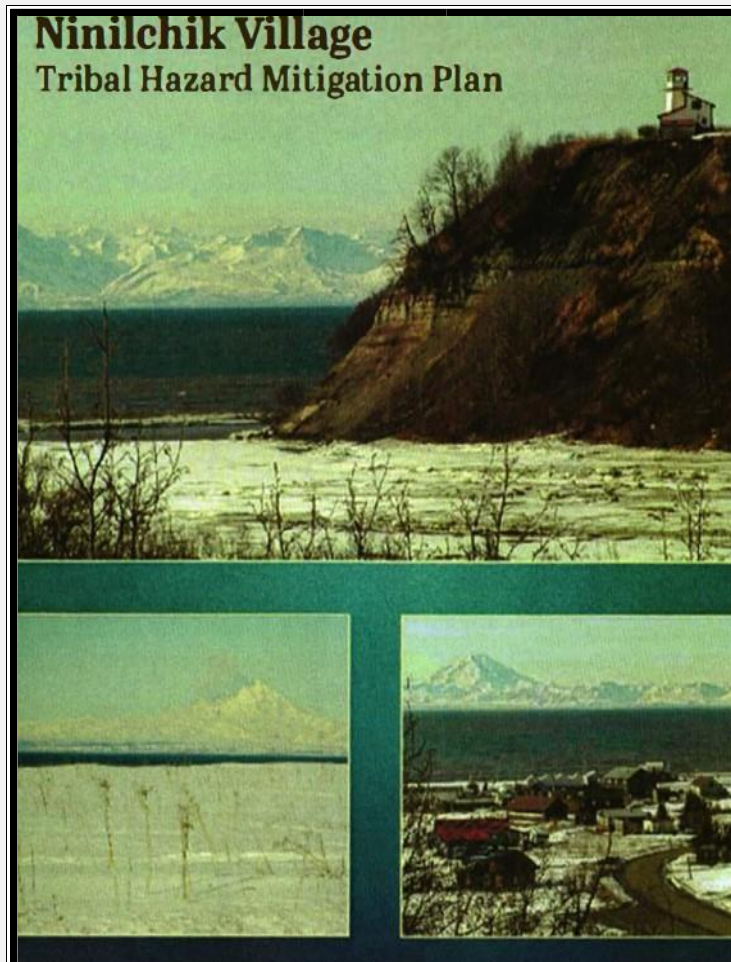

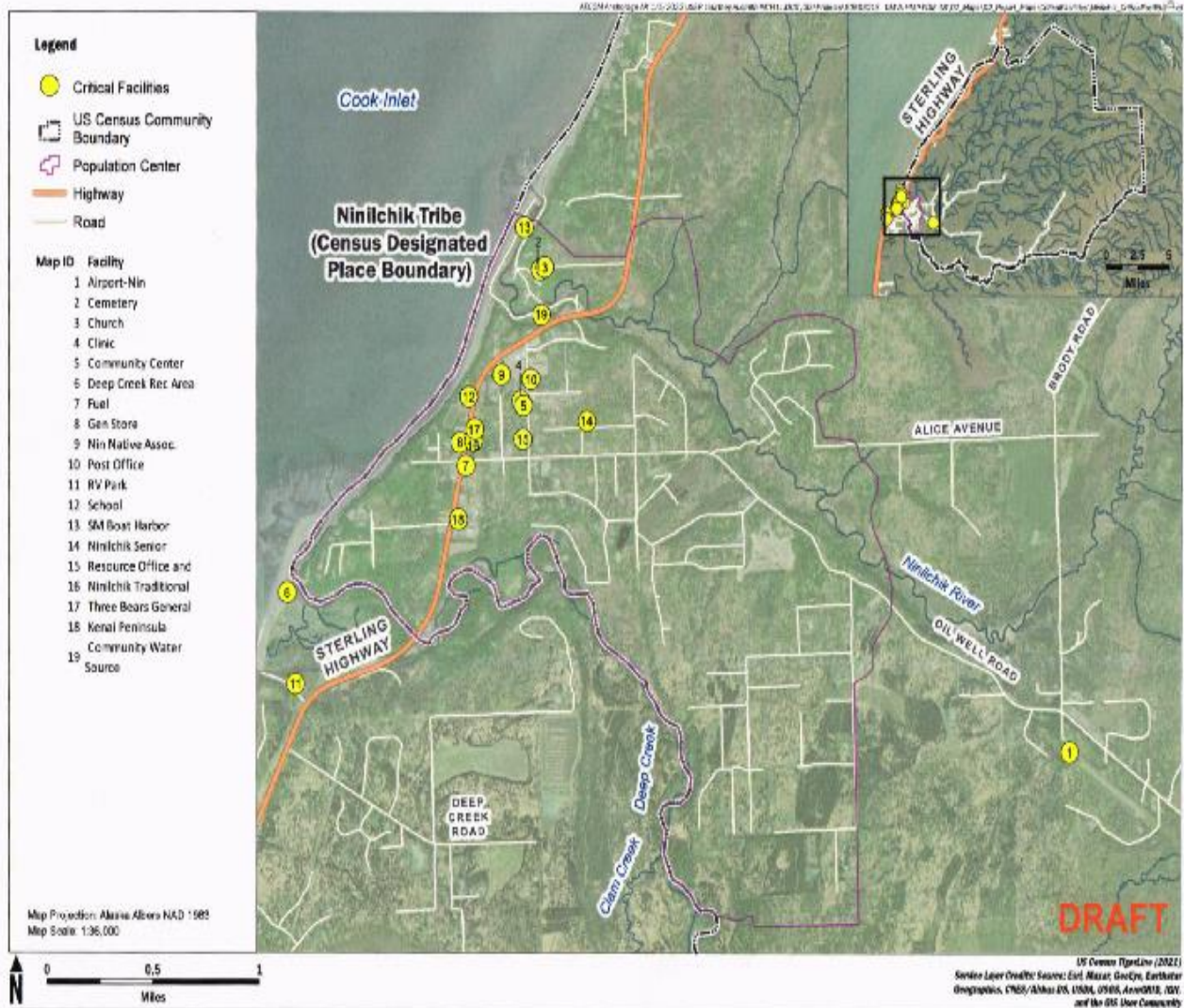

Elders Outreach Program

Elders Outreach Program Information



The Elders Outreach Program offers lunch at the Subsistence Building every Monday. The luncheon is still provided on holidays that the other NTC offices are closed. The luncheons, served at noon, coming up for the following months are;

Mondays in *February* 7th, 14th, 21st, 28th

Mondays in *March* 7th, 14th, 21st, 28th

Mondays in *April* 4th, 11th, 18th, 25th

As a friendly reminder, the luncheon exists to serve as a social space for enrolled Tribal Elders to gather, share, and visit. Elders are encouraged to bring a guest, family, or to be accompanied by a caregiver. There is a suggested donation box at the back for this purpose. While it is a provided luncheon for enrolled Tribal Elders to attend, it also serves many homebound enrolled Tribal Elders who cannot drive or have other needs that prevent them from attending. The luncheon is for these Elders, and we ask everyone attending to be mindful of others who are not able to attend. Any additional food will be provided and delivered to their homes.

We encourage active participation from the youth and strongly urge enrolled Tribal Elders to offer their experience, advice, knowledge, and techniques for activities. If you have a cultural/traditional skill, please call or email our office. We look forward to the Tribal Elders sharing a bit of their time and knowledge with the youth. Our office is open and welcomes your input to make this program grow and thrive.

We encourage you to utilize our areas that the Elders Outreach Program has designated for usage to alleviate subsistence and rural harvesting bounty. We have added a covered area over two large stainless-steel tables to help accommodate your needs during the fishing season. We have hoses, scrub brushes, and totes to use for breaking down your fish. We can also help with vacuum sealing your harvest and even freezing it in our walk-in freezer, should you need additional room. We have added a moose hanging room with a controlled temperature AC Unit. Should you want to hang your moose, we can offer room and capacity to do this whether it's a roadkill moose or a fall harvest. We do ask that you call and request these services ahead of time in order to properly give space and time for those seeking these services. Over the last year and a half, we have added a Smokehouse, a vacuum sealer, and a Harvest Right Freeze Drying machine available for your needs. We are happy to help assist you in breaking down your bounty and properly storing it as you need. Whether it's our large pressure cookers, meat grinders, or bone cutting saw, we have all of these tools available: some are for usage in house, and others we can help you facilitate on an as needed basis.



Elders Outreach Program

We would like to reach out to enrolled Tribal Elders regarding an upcoming project for collaboration on your views, thoughts, and experiences regarding *Aging out of your Community*, a project we are working on with Jordan P. Lewis, PhD, MSW (Aleut) and Dr. Steffi Kim. This is a research study regarding how we can support you aging in your homes and community successfully, as well as understanding culturally responsive activities that benefit all community members and honor and respect our cultural values, practices, languages, and history. This study is funded by the National Science Foundation. The effort of gaining this history and highlighting the resiliency of our Elders will be in your voices. We actively encourage you to please participate in this study for the future of our community goals. There will be time allocated for one-on-one interviews via Zoom or in person, whichever you are more comfortable with. We are also seeking to communicate with those who can advocate for Elders specifically in our community regarding barriers, preventative needs and obstacles, as well as highlights and positives regarding how Ninilchik Elders can benefit in the future for the continued desire of residing in their own community. 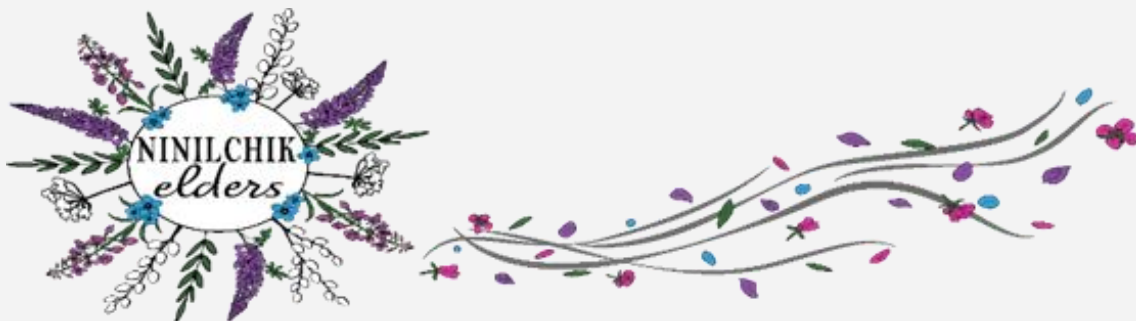

Mission

To promote safe and healthy environments that foster development through early intervention and education focusing on substance use prevention and suicide prevention.

The Youth Outreach Program strives to support community youth through various avenues year-round. Our team believes in the importance of youth having supportive adult mentors in their lives who can support them as they navigate their way through adolescence and young adulthood. The program has a strong emphasis on leadership, critical thinking, community service, culture, self-esteem, positive risk taking, community, and connection.

Teen Center:

The Teen Center is open on Fridays and is open to teens ages 12+ to come and hang out in a safe environment. Admission is free and there are concessions available to purchase. There are a wide range of activities for youth to interact with from card games, pool, and the most recent and popular addition ping pong!

Study Hall:

Academic support is available on Tuesday and Thursday 3:30-5:30. Students can find a quiet place to study and receive guidance on assignments. Tutoring can also be scheduled on an individual basis if Tuesday or Thursday do not meet your schedule needs.

FFA:

Students focus on leadership, community service projects, professionalism, post-secondary exploration, employment readiness skills, and outdoorsmanship.

GULU:

In partnership with Project Grad, students and mentors meet afterschool on Mondays to participate in various outdoor activities such as skiing, beach combing, trail hikes and so much more! Get outside!

October – April: The Ninilchik NYO team practices 3:35pm-5:15pm
Jr. NYO (1st-6th grades) Tuesday & Thursday. Sr. NYO (7th-12th grades) Monday & Wednesday.

Sources of Strength is designed to harness the power of peer social networks to change unhealthy norms and culture, ultimately preventing suicide, bullying, and substance abuse. The mission of Sources of Strength is to empower a well world and prevent suicide by increasing help-seeking behaviors and promoting connections between peers and caring adults. The first Advisor and Peer Leader training will take place early February at the Ninilchik School.

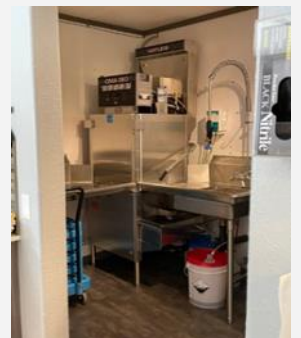
Ninilchik Village Tribe Community Center
