



The Ninilchik Village Tribe is a federally recognized tribe in Alaska, consisting of approximately 1,000 members. These members can trace their ancestry to Ninilchik tribal lands or are Alaskan Natives and American Indians who have settled within the tribal boundaries and have been accepted for membership. The tribe is governed by the Ninilchik Traditional Council, comprised of five elected council members who serve



three-year terms. They oversee tribal operations and uphold sovereignty using Organic Documents approved by the tribal membership.

#### **Executive Director's Address**



As we move out of the fall season, I hope your freezers are full of fish and moose. The Cook Inlet commercial set net season was closed once again and the educational fishery was very slow, with no kings allowed to be harvested and very few sockeye salmon caught. On a positive note, the federal subsistence fishery was extremely successful. The Resource Department was able to get 2,722 fish for the Ninilchik community in the Kasilof River gillnet, with another 2,174 harvested in the Kenai River. The crew fulfilled around 164 community household permits, totaling 4,896 salmon. Tiffany and Jessica in the Elders Program also helped folks with their fish processing as well. A huge thanks goes out to all these staff who made this possible.

On an exciting note, after years of working with the Cook Inlet Tribes to advance Tribal fishery issues and support our food security, we held our first meeting of the Tikahtnu Inter-Tribal Fish Commission (TFC). The majority of the Tribes in the Cook Inlet (Tikhatnu) have signed

onto TFC. Ninilchik's commissioners include Greg Encelewski as the Elder representative, Taylor Higgins as the Youth representative, and me as the primary commissioner. This spring we had a strategic planning session and developed the constitution which culminated in this amazing endeavor which is now operational.

The work on our tribal 8(a) company Tuyan, LLC is continuing to do very well. Our contracts with the Defense Logistics agency were renewed for 2025 and we ended fiscal year 2024 with a nice net profit. Fiscal year 2025 is projected to be even better. This included the addition of new employees to support our work moving forward with new task orders. I have also been working with US Treasury on the State Small Business Credit Initiative (SSBCI) program to highlight our program and how others can structure an investment like Tuyan, LLC.

The Council has completed its collaboration with the engineering and design team on the Cultural Heritage Center. The 95% engineering plans are developed and the interior designs have been selected. We are now moving into the permit acquisition phase for construction, which means we are currently in the fundraising stage to secure the necessary funds. While this process may take some time, we anticipate that the center will come to fruition within the next couple of years.

I want to remind you about our partnership with the Kenaitze Indian Tribe, which created Nił Qenach'delghesh ("we talk to each other" in Dena'ina). An agreement with SPITwSPOTS allows Tribal Member households to receive standard internet service free of charge, or a comparable discount on a higher-level service. Free or discounted internet service is available immediately; however, infrastructure upgrades may take up to two years to complete. According to recent information, they expect 20 tower sites to be fully operational by October 15th, with anticipated completion by the end of December. For those who cannot currently access service due to their location, these upgrades are happening at tower sites that may make service available in the future once the infrastructure is

updated. If you reside within the SPITwSPOTS service area and your Tribal Member household would like to receive service, please contact SPITwSPOTS directly.

In closing, there is so much to be excited about here at the Tribe. I hope you have a great fall and a prosperous winter.

Hello Ninilchik Tribe,

Another summer gone into the wind and rain. I do hope everyone was able to get their fish for the winter, garden goods harvested and were able to top it all off with a Moose. Yum!

We've started building another new home for a Tribal Member here in Ninilchik. This time, we're making a few tweaks, mainly testing out new types and brands of materials, including a new kind of vinyl siding. Our previous sidings have been too brittle in both cold and heat, leading to chips and cracks. This new option is designed to be more resilient against our harsh elements. Only time will tell how it performs, but we're committed to improving our homes with each project, incorporating the latest technology as it develops. If all goes according to plan, this home should be finished around Christmas!

#### Homeowner Assistance Fund (HAF) – U.S. Dept. of Treasury

We're still here to help homeowners facing financial hardship due to COVID-19. The Treasury's Homeowner Assistance Fund (HAF) grant may be able to assist you. This grant can support families with overdue mortgages, help stop foreclosures, and cover past-due property taxes and utilities. The program is open to homeowners of all races within our Tribal Boundary area. To qualify, household incomes must fall within 150% of the median income limits for the Kenai Peninsula Borough. You can find the application on the Housing page of the NTC website at www.ninilchiktribe-nsn.gov/housing.

#### Weatherization Program – NTC

As summer winds down and we start transitioning into winter, I urge you to assess what needs to be done around your home to prepare for the colder months. In addition to stocking up on wood and coal, consider when you last cleaned your chimney stove pipe. Taking care of these tasks now can help ensure a safe and cozy winter!

Our Weatherization Program can help cover the cost of materials to improve your home. To qualify, applicants must meet certain income requirements\*, and the work must align with the program's guidelines. Once awarded, we'll purchase the materials, and you or someone you know will need to complete the work. After that, we'll verify that the work has been done. It's a quick and simple way to get your home winter-ready! I recommend filling out an application so you can secure your materials before the snow arrives.

\*Current household income limits: 1 person - \$60,150; 2 people - \$68,750; 3 people - \$77,350; 4 people - \$85,900. For limits for larger households, please give me a call.

#### **Winter Prep**

Are your floors chilly? Cold floors indicate there's movement under your home. To fix this, you'll need to install skirting. If you already have skirting, make sure to insulate with blue board or a vapor barrier, along with insulation over the skirting from underneath your home. Be sure to overlap the areas where the skirting boards meet. This is a quick job to tackle, and it's much nicer to do when it's warm and there's no snow on the ground, allowing you to lay out the materials you're working with.

#### Notice of the NTC Annual Election

The 2024 NTC Annual Election date has been set as November 12, 2024 (per the Constitution of the Ninilchik Tribe, this is the deadline for ballots to be received, and no late ballots can be accepted). The purpose of this election is to elect one (1) Council member for a three-year term. NTC realizes that the Tribal Court does not currently have a working and functioning purpose, as it is in the early developmental stages. Therefore, the process of continuing to elect judges annually is not necessary and warrants suspension until further notice.

#### **Council Seat**

Any NTC registered voter, who resides within the Ninilchik Traditional Council's Tribal Boundaries, may run for a Council seat by simply filling out a Declaration of Candidacy Form. Please keep in mind that the Declaration of Candidacy forms must be received in the Ninilchik Traditional Council's Tribal Services Office no later than October 17, 2024, by 5 pm.

Any new candidate running for the Board, or any previous Board member seeking re-election, shall be deemed unqualified if found to be, in any capacity, an employee of NTC, either inactive, temporary or permanent, full or part time. However, no voter seeking election shall be placed upon the ballot if such voter has been convicted of or pled guilty or no contest to a felony offense involving dishonesty or moral turpitude within five (5) years of the date of the election; or has been found guilty of, or entered a plea of nolo contendere or guilty to, any felonious offense or any of 2 or more misdemeanor offenses under Federal, State, or tribal law involving crimes of violence; sexual assault, molestation, exploitation, contact or prostitution; crimes against persons; or offenses committed against children. Furthermore, no voter seeking election shall be placed upon the ballot if such voter has been previously recalled by election from the NTC Board within five (5) years of the date of the election. In addition, a successful candidate must provide the results of a drug test in the same manner as that required to be submitted by tribal employees before being installed into office. All Council members are subject to background investigation and Drug & Alcohol testing in accordance with the Ninilchik Traditional Council's Anti Drug and Alcohol Plan, in order to comply with appropriate Federal requirements. These are required because the Ninilchik Traditional Council administers programs with federal money, which mandates that the Tribe comply with mandatory background checks and drug-free certifications. Council members will, at times, have control or work directly with children and child custody issues. As a result, the Indian Child Welfare Act program, that the Tribe administers, requires copies of background checks.

The 2024 NTC election is conducted by mail and there will be no polling place open for in-person voting on Election Day. Ballots will be mailed on October 23, 2024. Any registered voter who does not receive a ballot by mail may request such a ballot in person, by phone, telefax, or mail at the Ninilchik Traditional Council's Tribal Services Office.

#### All ballots must be received by or on November 12, 2024

To ensure your ballot is counted, please mail it well in advance so that it reaches the Election Committee's Ninilchik post office by Election Day. Note that there is no postmarking deadline; ballots must be received by or on Election Day.

#### Your VA Benefits Are Welcome Here!

Please note that all non-urgent and non-emergent care requires authorization from VA in advance. How do you know if you're even eligible? See some requirements below or visit www.va.gov/health-care/eligibility.

We accept over 60 kinds of insurance including: Medicare, Medicaid, VA, and Tricare, as well as numerous private insurances. The NTC Community Clinics are preferred providers for patients enrolled with Blue Cross Blue Shield of Alaska.

#### Am I Eligible For VA Health Benefits?

You may be eligible for VA health care benefits if you served in the active military, naval, or air service and didn't receive a dishonorable discharge.

#### If you enlisted after September 7, 1980, or entered active duty after October 16, 1981

You must have served 24 continuous months or the full period for which you were called to active duty, unless any of the descriptions below are true for you.

This minimum duty requirement may not apply if any of these are true:

- You were discharged for a disability that was caused—or made worse—by your active-duty service, or
- You were discharged for a hardship or "early out," or
- You served prior to September 7, 1980

#### If you're a current or former member of the Reserves or National Guard

You must have been called to active duty by a federal order and completed the full period for which you were called or ordered to active duty. If you had or have active-duty status for training purposes only, you don't qualify for VA health care.

If you served in certain locations and time periods during the Vietnam War era You're eligible for VA health care.

### If you meet the basic service and discharge requirements and were exposed to toxins or other hazards while serving our country—at home or abroad

You're eligible for VA health care. This includes all Veterans who served in the Vietnam War, Gulf War, Iraq, Afghanistan, or any other combat zone after 9/11.

#### What Is Purchased/Referred Care (PRC)?

Ninilchik Clinic does not receive Purchased/Referred Care for any services outside of IHS-run facilities, including emergency room visits. If you do go to the emergency room, you must not only notify NTC, but also PRC at ANTHC at 800.478.1636, within 72 hours.


#### Purchased/Referred Care (PRC)

Medical/dental care provided at an Indian Health Service (IHS) or tribal health care facility is called Direct Care. The Purchased/Referred Care (PRC) Program at IHS is for medical/dental care provided away from an IHS or tribal health care facility. PRC is not an entitlement program and an IHS medical referral does not imply the care will be paid. If IHS is requested to pay, then a patient must meet the American Indian/Alaska Native tribal affiliation, residency requirements, notification requirements, medical priority, and use of alternate resources (including IHS facility).

All American Indians and Alaska Natives should be aware of the following requirements each time he/she is referred or requests IHS to pay for medical care away from an IHS or tribal health care facility:

- Patient responsibility to comply with ALL PRC requirements
- PRC is not an entitlement program
- PRC Eligibility Requirements
- PRC Notification Requirements
- PRC Patient Process for Authorization for Payment (Diagram Below)
- Medical/Dental Priority of Care
- Use of Alternate Resource (Medicare, Medicaid, VA, Private Insurance, charity, etc.)
- Appeal Process for Denial of PRC care
- Patient Rights & Responsibilities
- Directory for an IHS or tribal health care facility near your location



### THE INVASION OF INVASIVE WEEDS

Invasive weeds are spreading rapidly across Alaska, overtaking yards and roadside ditches. They suffocate native plants and create unfavorable conditions for their growth. The two most prevalent invasive weeds are Orange Hawkweed and Oxeye Daisy. If you find these plants in your yard, take action immediately to remove them. You can eliminate them by digging, mowing, or applying herbicides. It's best to remove these plants before they seed.

### WHAT'S THE BIG DEAL?

Invasive weeds are spreading across Alaska, carried by vehicles, ATVs, people, animals, and the wind. These invasive plants destroy habitats and significantly contribute to the decline of various plant and animal species. Some common invasive weeds include Tansy Ragwort, Oxeye Daisy, Narrow-leaf Hawksbeard, Orange Hawkweed, Canada Thistle, Scotch Thistle, Spotted Knapweed, Garlic Mustard, and Field Bindweed. Each of these plants impacts the environment in unique ways, making their swift removal essential.

### BUT THEY'RE SO PRETTY!

Orange Hawkweed, in particular, has become a major issue on the Kenai Peninsula, where it blankets many lawns and ditches. While it may appear attractive, this flower is harmful to other plants. Orange Hawkweed affects native species and livestock by producing phytotoxic chemicals in its pollen that inhibit the growth of other plants. Phytotoxic chemicals are substances that are toxic to the growth of surrounding vegetation.



### WHY DOES IT MATTER ANYWAY?

Invasive weeds disrupt ecosystems in several significant ways, including:

- » Displacement of Native Vegetation
- » Habitat Degradation
- » Increased Wildfire Risk
- » Alteration of Soil and Water Systems
- » Economic Impact
- Seffects on Human Health

### WELL, HOW DO I GET RID OF THEM?

There are several effective methods for removing invasive weeds:

- **Manual Methods:** Cutting or pulling the weeds by hand.
- **Mechanical Methods:** Using tools like mowers or tillers to disrupt the weeds.
- **>> Chemical Methods:** Applying herbicides to target invasive species.
- **Biological Methods:** Introducing natural predators, such as grazing animals or insects, to help control the plants.







### WHY DOES IT MATTER ANYWAY?

You can take several steps to help prevent the spread of invasive weeds:

- **Clean Your Gear:** Always clean your gear when traveling.
- **Wash Your Vehicle and Boots:** Make sure to wash your vehicle, boots, and equipment.
- **>> Choose Native Plants:** Opt for native plants in your garden instead of invasive species.
- **Dispose of Plant Waste Properly:** Ensure that plant waste is disposed of correctly.
- **Report Sightings:** Notify the 1-877-INVASIV hotline if you spot any invasive plants.
- **Spread Awareness:** Educate others about invasive plants and promote adherence to regulations regarding the transportation and use of plants and animals.




